Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

The PHA maintains strong internal controls, develops and maintains a strong culture of mutual respect. Our employees and stakeholders maintain a high level of responsibility and ethical behavior. In achieving the PHA goals, the PHA applied and was accepted into HUD's Move to Work (MTW). The MTW will provide numerous benefits to the PHA including authority to waive statutory and/or regulatory barriers, ability to create policies that address local needs, rethink the current administration of the HCV program, become an industry leader among other benefits. The PHA is also maximizing funding eligibility by maintaining a 98% minimum lease up rate. The PHA maintains high customer satisfaction by responding to complaints within 24 hours. The PHA continues to improve its briefing procedures for program participants by providing the most updated information in compliance with HCV program regulations. The PHA continues to affirmatively further fair housing by ensuring access to assisted housing regardless of race, color, religion, national origin, sex, familial status, and disability by conducting annual workshops for participants and prospective owners within the PHA's jurisdiction. PHA complies with 24 CFR 5.2007(3)]. Progress: The City of Pomona HA continually revises its administrative plan to incorporate and comply with the most recent VAWA regulations. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
