How the Program Works

The SoCalREN Multifamily Program is designed to help your multifamily customers save money and add value to their property. Customers follow a simple process as outlined below, with help and support from our program team every step of the way.

- Complete program enrollment documents
 Provide high-level information about the property and energy systems.
- Submit project scope and cost estimate
 Our technical staff will complete an energy
 assessment and identify retrofit opportunities.
 You will work with the customer to select which
 energy efficiency measures to move forward with.
- Complete energy efficiency retrofit
 Install measures agreed to in project scope and notify your account manager to schedule post inspection when all measures are installed.
- Receive incentive payment
 Incentive checks will be mailed 4–6 weeks after project is inspected and approved by the program.
